Today, the U.S. Food and Drug Administration issued a safety communication informing the public that results from SARS-CoV-2 antibody tests should not be used to evaluate immunity or protection from COVID-19 at any time, and especially after the person received a COVID-19 vaccination."

The FDA document, dated May 19, 2021, is titled: <u>"FDA In Brief: FDA Advises Against Use of SARS-CoV-2 Antibody Test Results to Evaluate Immunity or Protection From COVID-19, Including After Vaccination"</u>.

Digging a little deeper in the document, we have a statement referring to the COVID vaccine:

The authorized vaccines for prevention of COVID-19 induce antibodies to specific viral protein targets; post-vaccination antibody test results will be negative in individuals without a history of previous natural infection if the test used does not detect the type of antibodies induced by the vaccine." In other words, the FDA is saying, "Look, the vaccine creates specific antibodies against the spike protein, not the virus. If you take the standard antibody test after vaccination, it'll be useless, because the test isn't meant to detect antibodies against the spike protein. It only detects antibodies against the virus." 


